EXHIBIT SPACE AGREEMENT

ASSIGNMENT OF SPACE

The Straz Center will try to honor all exhibitors request for site location at the Bridal Show. Final determination of space assignments will be made and changed in the best interest of the Show as determined by the Straz Center for the Performing Arts.

PAYMENTS AND REFUNDS

The signed agreement along with full payment is due on or before Feb. 1, 2012. Otherwise, the space will not be held or guaranteed. The Exhibitor will be refunded any amount paid – minus \$100 (non-refundable) – if cancellation notice is received on or before Feb. 14, 2012. No refunds will be made after that date.

TERMINATION OF CONTRACT

The Straz Center reserves the right to cancel this contract at any time before the Show opening. If that happens, the exhibitor will be released of any obligations of the agreement and a full refund will be paid to the exhibitor. If the Straz Center determines that the date of the show should be postponed, no refunds will be made.

LIABILITY OF PROPERTY

The Straz Center is not responsible for any damage or loss to any exhibit materials that are brought for the show. It is the responsibility of the Exhibitor to remove any materials that are brought and used for the show. Items that are left will be discarded.

AGREEMENT ACCEPTANCE

Upon acceptance of this Agreement by the Exhibitor and the Straz Center for the Performing Arts, it shall be a legal binding Contract, provided each party may cancel within the conditions of this Agreement.
