It is my pleasure to tell you that the Straz Center for the Performing Arts is thriving.

This 2021-22 Report to the Community summarizes Judy Lisi's final year as President and CEO of the Straz Center. The year reflects the culmination of her 30 years of hard work and leadership through its most successful seasons, the closed doors of COVID and our emergence from the pandemic.

During her 30-year tenure, The Straz became one of the most formidable performing arts centers in the nation. The relationships Judy built with the New York theater community made The Straz the Broadway of the South. Dance, comedy, theater, lecture, pop and classical music, and, of course, opera also flourish at The Straz. Her commitment to arts education shines in the bright faces of our students attending the Patel Conservatory and her legacy forever grows through Straz outreach programs in area schools and underserved communities.

Judy's focus on issues that impact all sectors of our community launched The Straz's Inclusion, Diversity, Equity and Accessibility (I.D.E.A.) initiative that nurtures an organizational culture that advocates anti-racism, equity and belonging on our campus and beyond.

Our Voices of the Community virtual town halls cultivate relationships and highlight topics important to Black, Indigenous and People of Color. And Arts Legacy REMIX is a diverse celebration of music, dance and storytelling rooted in cultures of the Tampa Bay area.

All of us – from the staff, students, donors, outreach recipients and the countless who grace our stages and sit in our theaters – are forever grateful for her guardianship and remain committed to her vision for The Straz.

Judy left all of us a firm foundation to stand on, one that I am very excited to continue to build upon.

Judy Lisi's Legacy Lives

UNDER JUDY'S TUTELAGE, PATEL CONSERVATORY AND OPERA TAMPA WERE BORN AND THE RESTRUCTURED BROADWAY SERIES MADE THE STRAZ ONE OF THE NATION'S MOST SUCCESSFUL PERFORMING ARTS CENTERS.

When Judy Lisi came to the Straz Center for her interview with the search committee in 1992, she drove right past the enormous concrete structure — there was not one sign on the building. She got the job and six months later there was bright neon signage illuminating the facility. Thirty years later, her light still shone bright as she stepped down from her job into retirement. Her name and Straz Center for the Performing Arts are practically inseparable and the legacy she left will cast its light for years to come.

Lisi took the reins at what was then the Tampa Bay Performing Arts Center (TBPAC) in 1992. At that point, the financially troubled TBPAC was an under-utilized facility that no one seemed to know what to do with and was weighed down with a \$5 million accumulated deficit.

After restructuring, completely upgrading marketing and programming, especially the Broadway series, Lisi retired that debt in her first year on the job. She raised Broadway subscription from 1,500 members to 10,000, becoming one of the most successful touring Broadway markets in the country. She also established a creative, flexible, dynamic and cost-effective in-house advertising agency.

Over the years she's made tremendous additions to the performing arts center. She recognized the aesthetic excellence of the main halls which were inspired by European opera houses — but Tampa did not have a professional opera company. Lisi, who studied opera at Juilliard and established an opera company in New Haven, Conn., founded Opera Tampa in 1996 to great acclaim.

Lisi started her career as an educator and recognized the enormous benefit of arts education. She expanded the Straz Center's arts education programs. Due to the tremendous growth of these programs, she founded the Patel Conservatory which opened its doors in 2004 and attracts students from around the world.

When the performing arts center opened in 1987, there were three performance spaces — now there are six. There was a need for a theater to be available for local groups. And so Lisi converted a space used for storage to the innovative Hinks and Elaine Shimberg Playhouse, from which new theater groups emerged including Jobsite and Stageworks. The TECO Theater is a black box theater in the Conservatory designed for educational purposes. And the newest venue is the Riverwalk Stage which is an open-air space on the Hillsborough River.

Additionally, Lisi converted a rehearsal hall into Maestro's Restaurant and brought all food and beverage operations in-house, raising the quality, boosting service levels and generating revenue.

Prior to her move to Tampa, Lisi was executive director of the prestigious Shubert Performing Arts Center in New Haven. While there, she retired a \$1.1 million deficit and brought in thousands of new Broadway series subscribers.

A few years before, Judy had a completely different life in mind — she had planned to become a nun. She entered the convent at 17 and left at 20. "It was great," she told the *Tampa Bay Times*. "I loved it. I could have been a very happy nun." She

left the order to help support her mother and younger sister after her father passed away.

The convent's loss was performing arts' gain.

At the Shubert, Judy revived an already storied facility that had hosted tryouts for almost a dozen Richard Rodgers musicals as well as the first production of Tennessee Williams' *A Streetcar Named Desire* starring Marlon Brando.

TBPAC by contrast, had been around only five years and had little history to speak of when Judy first saw it in 1992. Judy recognized the potential to turn it into a vital part of the Tampa Bay arts community.

For her hardwork, Judy has received numerous national and international awards including the International Society for the Performing Arts' Patrick Hayes Award for transformative leadership in the performing arts and the Broadway League's Distinguished Lifetime Service

Award. She has been inducted into the Tampa Bay Business Hall of Fame and in the fall of 2022 she received the Tampa Business Committee for the Arts Lifetime Achievement Award.

Of course, she didn't do it all by herself. "I love the collaboration," Judy said. "You can't do this thing alone. You can lead – and you have to – but you must work so closely with people."

"Judy is a wonderful collaborator!" said Alice Santana, the Straz's vice president of education and community engagement. "Judy is very supportive of any project or initiative that aligns with our mission. She has provided me wonderful guidance and thoughtful opinions."

Judy also oversaw the facility's name change when philanthropist David Straz made a substantial donation. TBPAC became the David A. Straz, Jr. Center for the Performing Arts in 2009.

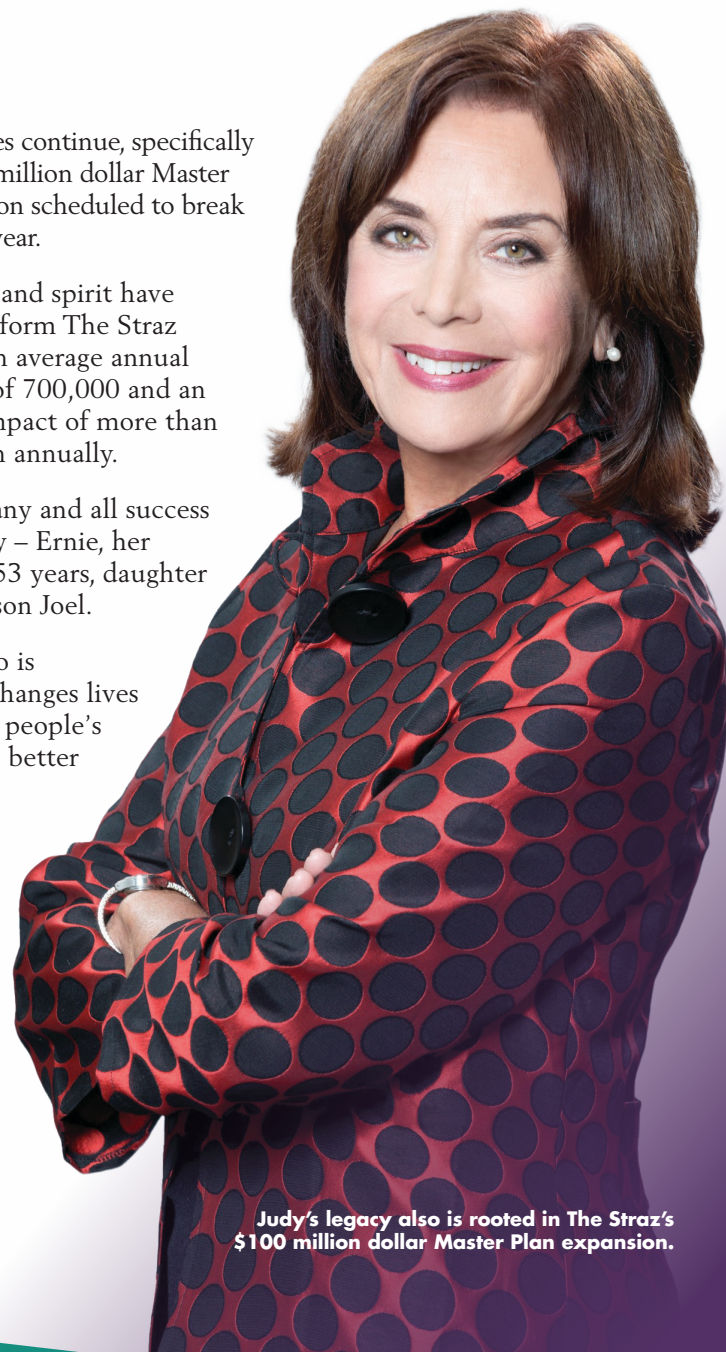
Judy's legacy will be felt in the rich blend of arts and entertainment offered by The Straz, as well as in the talents she nurtured here.

Her initiatives continue, specifically in the \$100 million dollar Master Plan expansion scheduled to break ground this year.

Judy's drive and spirit have helped transform The Straz which has an average annual attendance of 700,000 and an economic impact of more than \$100 million annually.

Lisi credits any and all success to her family – Ernie, her husband of 53 years, daughter Rachel and son Joel.

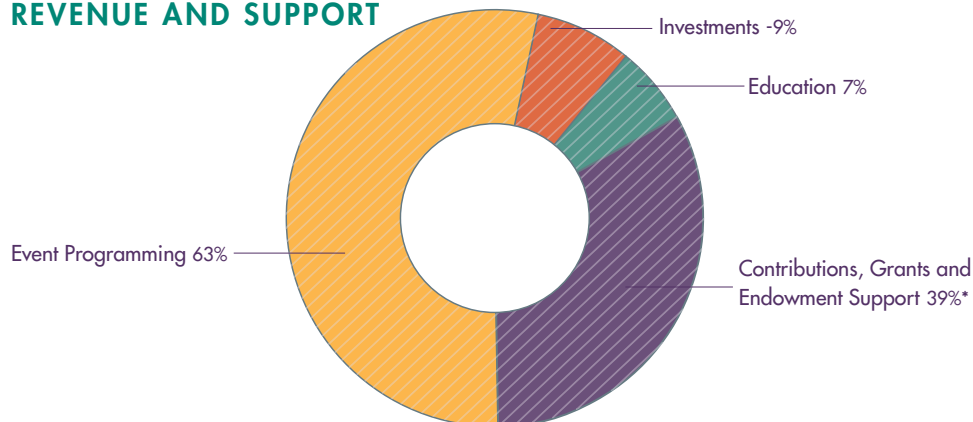

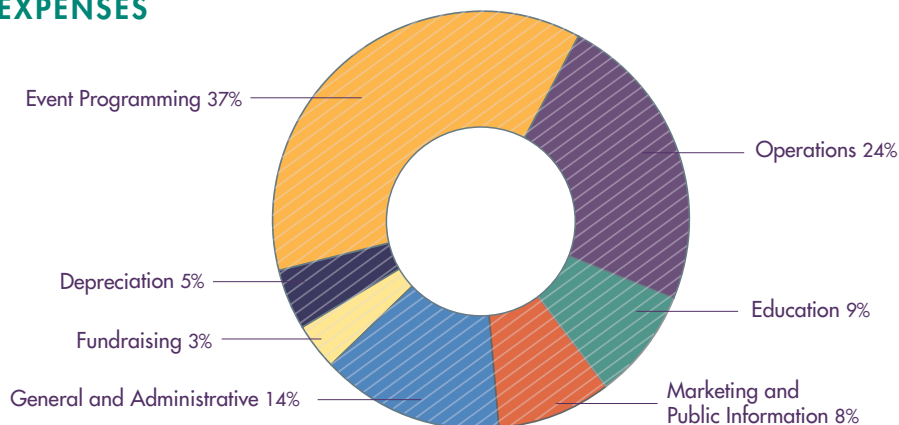
