# ER DAY, DESTINY



Dear Friends,

Perhaps the brightest highlight of last season, *The Choir of Man* struck a chord with Straz audiences. As part of our “only at Straz Center” producing pillar, *The Choir of Man* could only be seen in two locations last year: on London’s West End and in Tampa at Jaeb Theater in fall 2023. This Straz Produces staging kept crowds streaming into Jaeb Theater, so much so that the UK import’s original two-month run was extended into December.

*Choir* is set in a British pub with actors portraying the regulars. It’s a rousing, 90-minute celebration of beer, camaraderie and earworm Top 40 hits. It’s also a celebration of community.

The Tampa Bay area community is a vital part of what Straz is about. After all, it’s where most of the half million guests we greeted in 2023-2024 come from. Our commitment to the arts goes hand in hand with our commitment to our community.

That commitment is reflected in our Arts and Health programming and our outreach to active-duty military, veterans and families. It’s seen in our

educational programs which make the arts accessible to 80,000 participants through programs on our stages, in our Patel classrooms, via a U.S. Department of Education grant for field trips and in our work with more than 40 community partners.

Our Arts Legacy: REMIX presentations incorporate dance, music and storytelling as we explore our area’s diverse cultural roots. Our virtual town hall meetings, Voices of the Community, provide a safe space to discuss stories and experiences, while our BIPOC play reading series highlights the dramatic works of authors who are black, indigenous or persons of color.

In 2023-2024, Straz offered 1,394 performances and events and we welcomed more than 500,000 on-campus guests attending those performances and events.


And what performances they were: *Beetlejuice* set a record for most tickets sold for a single-week run. That’s a fine way to kick off a Broadway season, which also featured inspired revivals of *Funny Girl* and *Company*, the

sensory spectacle of *Moulin Rouge! The Musical*, the all-time classic *Peter Pan*, and more.

All told, Straz generated a \$131 million economic impact in our area, as well as more than \$4 million in local and state tax revenues.

We know our success depends on the generosity of our donors. Thanks to your gifts, we can bring the arts to schools and communities that would go without otherwise; active-duty military, veterans and their families have resources to aid their return to civilian life. More students will be exposed to the arts; and so much more.

This annual report helps quantify our efforts at bringing the arts and education to our community. Thank you so very much for helping to make it all possible.

# In a word, EXTRAORDINARY the 2023-24 Season was

We aim to make every season extraordinary here at Straz. Some seasons, though, go even beyond to become extraordinarily special. Last season was extra-extraordinary for us, because in addition to presenting, we were also part of the behind-the-scenes production on shows, including *The Choir of Man* and *Stranger Sings! The Parody Musical*.

We had a feeling Straz audiences would take to *The Choir of Man* in a big way. The feel-good musical lit up London's West End before making its way to the states. Word-of-mouth – and whatever you call word-of-mouth on the internet – was great: lots of “best thing I’ve ever seen” and the like.

Plus, if you showed up a little early, you could have a beer – on the house! – and chat with cast members before the show.

Still, we committed Jaeb Theater to portraying *The Jungle* – the locale for the *Choir* mates – for two months. Sure, we hedged our bet a bit with free beer, but what if Tampa heard the *Choir* and just shrugged?

Happily, Tampa didn't shrug. Audiences left the show as converts, proclaiming their love of the *Choir* to friends, family and possibly random strangers. Demand was so great that the show's run was extended into December.

The show's success was particularly sweet for us. Straz was intimately involved in this production, from turning Jaeb into a British pub to partnering with local brewery Coppertail Brewing Co. to provide the beer to be served by *The Jungle*. (The brew was the decidedly Floridian Sun Runner, a tropical wheat ale flavored with pineapple and passion fruit.)

Straz is committed to not only bringing our community the finest theatrical entertainment. We want to create unique experiences for our audiences. We are focused on producing and presenting works here that, we hope, will resonate with our audiences specifically, including shows aiming for Broadway.

This season also brought us *Stranger Sings*, a hilarious musical parody of the television series *Stranger Things*. *Stranger Sings* was locally produced and included familiar names among the credits, such as lighting designer Jo Averill-Snell.

Of course, we'll continue to bring the best of Broadway to town, as we did in 2023-2024: the surreal splendor of *Moulin Rouge! The Musical*, the crowd-pleasing high jinks of *Beetlejuice*, the revelatory revival of *Company* and more.

Jobsite will continue to offer thought-provoking, innovative and intimate productions in Shimberg, and occasionally more ambitious productions in Jaeb. The season's schedule ranged from the outrageousness of *The Rocky Horror Show* to the stark portrayals of *The Beauty Queen of Leenane*.

And Opera Tampa will continue to present original productions of both familiar and less celebrated but deserving works. Opera Tampa has been leading the way on local productions, with most of their presentations being assembled from the ground up.

All of us at Straz Center will continue to strive to bring the arts to all of our community. We believe in the power of the arts to inspire and connect people. We promote the power of the arts through our commitment to (extra) extraordinary artistic innovation and bold storytelling.

We are proud to bring you creative works nurtured and produced at Straz Center. From Opera Tampa's ambitious 30<sup>th</sup> anniversary season, the BIPOC reading series of original works and Straz-produced theater, next year our spotlight will continue to shine on works that are extraordinarily entertaining.




## Revenue and Expenses


